Terms and Conditions

1. Scope of License.

Authorized Users: This Agreement authorizes simultaneous, Site-wide, online access to all Authorized Users by means of the Institution’s designated IP addresses. If a proxy server is being registered for access, the Institution agrees to maintain the security of the access by authenticating Authorized Users before allowing use of the proxy to any remote or on-site user. “Authorized Users” are employees, faculty, staff, or students officially affiliated with the Institution, and authorized on-site patrons of the Institution’s library facilities.

Interlibrary Loan: The Institution may use copies of chapters, journal articles, or similar quantities of material derived from the Content for the purpose of interlibrary loan with the same limitations that apply to copies for that purpose made from the print editions of the books or journals concerned. Copyright and other notices on the copied material may not be removed or obscured.

Interlibrary loans may be made only to academic libraries located within the same country as the Site. If the Site is located in the United States, interlibrary loan must be made in compliance with Section 108 of the Copyright Act of the U.S. and be within the CONTU Guidelines. If the Site is located outside the United States, interlibrary loan transactions may not exceed what is permitted under local law.

Educational Use: Authorized Users may reproduce particular chapters, journal articles, or similar quantities of material derived from the Content in “e-reserves” or similar platforms for the use of students in a particular course on a password-protected basis, provided that any material placed in e-reserves will be deleted at the conclusion of the course to which it relates. If access under this Agreement otherwise terminates during the term of such course, the e-reserve copy may be maintained until the termination of the course.

Other Uses: Authorized Users may download, print, and archive on their computers, for their own personal use, individual chapters, journal articles, and similar quantities of material derived from the Content, and may share such material with other scholars, but may not cumulatively reproduce any entire book or journal issue.

Automated searching or downloading by use of scripted searches, robots, spiders, crawlers, or otherwise, is prohibited. Downloading of data is permitted solely for the Institution’s internal use to the same extent as the printed version of the Content. Recompiling, publication, or republication of the Content, or any portion thereof, in any form or medium whatsoever, may be done only with specific written permission from the AMS (reprint-permission@ams.org).

Authorized Users may not (i) create derivative products or services that would compete with or negatively affect The Licensor’s products or services, or otherwise commercially use or allow commercial use of the Content, and (ii) will use reasonable best efforts to prevent a third party from gaining access or using any of the Content.

Licensee and Authorized Users may not:

1. use the Subscribed Products in combination with an artificial intelligence tool to the extent doing so would: create a competing commercial product or service for use by third parties; unreasonably disrupt the functionality of the Subscribed Products; or reproduce or redistribute the original Subscribed Products to third parties. Artificial intelligence tools may not be used without reasonable information security standards to undertake, mount, load, or integrate the Subscribed Products on Licensee’s or Authorized Users’ servers or equipment.

Further, *third-party generative* artificial intelligence tools may not be used with the Subscribed Products unless: (i) the tool is used locally in a self-hosted environment or closed hosted environment solely for use by Subscriber or Authorized Users; and (ii) the tool is not trained or fine tuned using the Subscribed Products or any part thereof, unless: such training is made by Subscriber or Authorized Users only; there is no public release or exchange of the trained artificial intelligence tool or its data with a third party; and neither the Subscribed Products nor any part thereof is shared with a third party.

An Authorized User may not permit access to the Content to anyone other than another

Authorized User, whether by link, or permitting access through his or her terminal or computer, or password-sharing, or by any other means or arrangement.

The Institution will make reasonable efforts to maintain security and monitor all use (including unauthorized use) from the Site.

Authorized Users will be bound by the provisions of this Paragraph 1 and by the Terms of Use (<https://www.ams.org/about-us/tou>) posted from time to time on the AMS website, except to the extent (if any) that such provisions may be inconsistent with the express terms of this license. The Institution will be responsible for ensuring that its Authorized Users are aware of the provisions of this Paragraph 1 and the Terms of Use.

All uses not authorized above or in the Terms of Use are prohibited. Promptly upon becoming aware of any unauthorized use of the Content or breach of the security of the Content's files, the Institution shall inform the AMS and take appropriate steps to end such activity and to prevent any recurrence.

- 2. Access; Accessibility.** The Site will have perpetual access on the AMS server for the year(s) subscribed to and backfile(s) purchased, at no additional cost, subject to Paragraph 6 below. The Content is archived in CLOCKSS and Portico.

Although AMS endeavors to make its electronic publications accessible to persons with disabilities as set out in its Website Accessibility Statement (<https://www.ams.org/about-us/accessibility>), it will have no liability for failure of any Content to be accessible by a disabled Authorized User. The Institution shall have the right to adapt Content as necessary to make it accessible to Authorized Users who are print-disabled and who cannot access such Content on the AMS server, provided that any electronic files created in connection with that adaptation shall be password protected and shall not be shared with any other entity. .

- 3. Term and Fees.** The term of this Agreement begins as soon as AMS has received both this signed Agreement and the full fee for the Content. For subscribed Content, this Agreement will last thereafter through the end of the calendar year in which the fee was received, and will remain in effect thereafter for successive calendar years so long as annual subscription fees are paid. Either party may terminate this Agreement, effective on the next renewal date, by at least 30 days' written notice to the other party. The annual fee for this subscription may be raised by written notice to the Institution, given at least three months prior to the next succeeding renewal date. The fee for each year this Agreement is renewed must be paid on or before the renewal date or the renewal will be invalid.
- 4. Support.** AMS electronic publications include online documentation. In addition, the AMS will provide the Institution with email and/or telephone support service during the AMS's normal business hours (Monday-Friday, 9:00 a.m. to 4:00 p.m., ET, excluding holidays). The email address for technical support is eprod-support@ams.org; the telephone number for support is 800-321-4267.

5. **Usage Data.** AMS provides Content usage data in accordance with the COUNTER code of practice and applicable data protection and privacy laws. This data will be made available to the licensee through a secure network.
6. **Copyright.** AMS retains copyright and all other rights in the Content. The rights granted herein to the Institution are non-exclusive, non-transferable, and non-sublicensable, and do not in any manner restrict or limit the rights of AMS.
7. **Suspension or termination of access.** The AMS reserves the right to suspend and/or terminate access to AMS electronic publications without prior notice if the Institution or its authorized users violate any term of this Agreement. Any use of AMS electronic publications beyond the scope of the License or any fraudulent, abusive, or otherwise illegal activities may be grounds for termination of access.
8. **Disclaimer of Warranties and Limitation of Damages.**
 - a. The AMS has made and will make good faith efforts to ensure that AMS electronic publications are complete and accurate. However, the AMS does not warrant completeness or accuracy, and does not warrant that the Institution's use of AMS electronic publications will be uninterrupted or error-free, or that the results obtained will be useful or will satisfy the Institution's requirements.
 - b. The AMS warrants that it is entitled to grant the licenses outlined in this Agreement, but makes no other warranties or representations of any kind, expressed or implied, including but not limited to warranties of merchantability or fitness for a particular purpose.
 - c. The AMS will not be liable for any delay, down time, or other failure of performance, but will use reasonable efforts to correct any performance problem brought to its attention.
 - d. The AMS will not be responsible for incidental, consequential, or any other damages arising out of or in connection with the service or materials provided hereunder. In no event may damages of any kind payable to the Institution on any grounds exceed the total of the purchase price, and one year's subscription fees, paid by the Institution hereunder.
 - e. The Institution assumes the sole responsibility for all use of AMS electronic publications by their authorized users and agrees to indemnify and hold the AMS harmless from any liability or claim of any person arising from such use. Subject to the other provisions of this agreement, the AMS will indemnify and hold the Institution harmless from any liability or claim of any person based on allegations that the AMS's provision of electronic publications hereunder is unlawful, including but not limited a claim that, if proven, would establish a breach of the warranty stated above.
9. **General.**
 - a. The AMS Privacy Statement (<https://www.ams.org/about-us/privacy>) is hereby incorporated by reference in this Agreement.
 - b. This Agreement constitutes the entire agreement of the parties and supersedes any prior communication between the parties with respect to the subject matter hereof.

Only a written instrument signed by both parties may amend it. Without limitation of the foregoing, any purchase order or other instrument that the Institution may issue for AMS electronic publications is for the Institution's internal purposes only and will in no way modify, add to, or subtract from the terms and conditions provided herein.

c. The Institution may not assign or transfer its rights under this Agreement.
