WHEREAS the Publisher holds the rights granted under this License.

AND WHEREAS the Licensee desires to use the rights and the Publisher desires to grant to the Licensee the license to use the rights for the Fee, subject to the terms and conditions of this License.

IT IS AGREED AS FOLLOWS: -

1. KEY DEFINITIONS

1.1 In this License, the following terms shall have the following meanings: -

Representative

A third party appointed from time to time by the Licensee to act on the Licensee's behalf, who may undertake any or all of the obligations of the Licensee under this License, as agreed between the Licensee and the Representative.

Archived Materials

The electronic material as set out in Schedule 1 or in new Schedules to this License that may be agreed by the parties from time to time.

Authorized Users

Members of the staff of the Licensee (whether on a permanent, temporary, contract or visiting basis) and individuals who are currently studying at the Licensee's institution, who are permitted to access the Secure Network from within the Library Premises or from such other places where Authorized Users work or study (including but not limited to Authorized Users', offices and homes, halls of residence and student dormitories) and who have been issued by the Licensee with a password or other authentication together with other persons who are permitted to use the Licensee's library or information service and access the Secure Network but only from computer terminals within the Library Premises.

Commercial Use

Use for the purposes of monetary reward (whether by or for the Licensee or an Authorized User) by means of sale, resale, loan, transfer, hire or other form of exploitation of the Archived Materials. For the avoidance of doubt, neither recovery of direct costs by the Licensee from Authorized Users, nor use by the Licensee or by an Authorized User of the Archived Materials in the course of research funded by a commercial organization, is deemed to be Commercial Use.

Course Packs

A collection or compilation of materials (e.g. book chapters, journal articles) assembled by members of staff of the Licensee for use by students in a class for the purposes of instruction.

Electronic Reserve

Electronic copies of materials (e.g. book chapters, journal articles) made and stored on the Secure Network by the Licensee for use by students in connection with specific courses of instruction offered by the Licensee to its students.

Fee

LTA /LAN FA

The Fee set out in Schedule 3 or in new Schedules to this License which may be agreed by the parties from time to time.

Journal The Journal forming part of the Archived Material, as specified in Schedule

Library Premises The physical premises of the library or libraries operated by the Licensee, as specified in Schedule 2.

Maintenance Fee The annual fee payable by Licensee to Publisher following the first year of perpetual access.

Publisher's A third party appointed from time to time by the Publisher to

Representative act on the Publisher's behalf, who may execute this License on behalf of the Publisher and undertake any or all of the Publisher's obligations under this License, as agreed between the Publisher and the Publisher's Representative.

Secure Network

A network (whether a standalone network or a virtual network within the Internet) which is only accessible to Authorized Users approved by the Licensee whose identity is authenticated at the time of log-in and

periodically thereafter consistent with current, reasonable practice.

Server The server, either the Publisher's server or a third party server designated by the Publisher, on which the Archived Materials are mounted and may be accessed.

That period stipulated in clause 2.2 below which shall cover access to the Archived Materials listed in Schedule I regardless of the original date of

publication of said Archived Materials.

2. AGREEMENT

Term

1 TO 1000 F

2.1 The Publisher agrees to grant to the Licensee the non-exclusive and non-transferable right to give Authorized Users access to the Archived Materials via a Secure Network for the purposes of research, teaching and private study, subject to the terms and conditions of this License, and the Licensee agrees to pay the Fee. The Representative will be responsible for processing payment of the Fee (and will be entitled to receive any refund of the Fee) on behalf of the Licensee, unless notified otherwise, in which case the Fee will be paid by the Licensee direct to the Publisher or Publisher's Representative.

The Term of this License shall commence on Sept. 1, 2010 and shall continue in perpetuity unless terminated by either party under clause 10 below.

2.3 On termination of this License:

2.3.1 the Publisher shall, when requested in writing by the Licensee, provide the Archived Materials to the Licensee in an offline electronic file format, but on the understanding that the Publisher shall be entitled to charge a nominal additional fee for providing the Archived Materials in such a format, such additional fee to be negotiated by the parties at the time.

2.3.2 notwithstanding 2.3.1, should this Licence terminate on the grounds of clause 10.1.4 below, the Publisher may in certain circumstances no longer have the right to fulfil the terms of clause 2.3.1 in respect of a particular Journal, but the Publisher undertakes to try to avoid this by using all commercially reasonable endeavours to ensure that any sale or re-assignment of any part of the Licensed Materials is without prejudice to the ongoing fulfilment of the terms of this Licence.

3. USAGE RIGHTS

- 3.1 The Licensee, subject to clause 6 below, may:
 - 3.1.1 Allow Authorized Users to have access to the Archived Materials from the Server via the Secure Network.
 - 3.1.2 Provide, or permit the Representative to provide, Authorized Users with integrated access and an integrated author, article title, abstract, and keyword index to the Archived Material and all other similar material licensed from other publishers.
 - 3.1.3 Provide printed or electronic copies of single articles at the request of individual Authorized Users.
 - 3.1.4 Display, download or print the Archived Materials for the purpose of internal testing or for training Authorized Users or groups of Authorized Users.
- 3.2 Authorized Users may, subject to clause 6 below:
 - 3.2.1 Search, view, retrieve and display the Archived Materials.
 - 3.2.2 Electronically save parts of the Archived Materials for personal use.
 - 3.2.3 Print off single copies of parts of the Archived Materials.
 - 3.2.4 Distribute single copies of parts of the Archived Materials in print or electronic form to other Authorized Users.
 - 3.2.5 <u>Scholarly Sharing.</u> Authorized Users may transmit to a third party in hard copy or electronically, minimal, insubstantial amounts of the Licensed Materials for personal use or scholarly, educational, or scientific research or professional use but in no case for resale or commercial purposes.

4. SUPPLY OF COPIES TO OTHER LIBRARIES

4.1 Using secure electronic, paper, or intermediated means such as Ariel, Licensee may fulfill occasional requests from other institutions, a practice commonly called Interlibrary Loan.

Licensee agrees to fulfill such requests in compliance with Section 108 of the United States Copyright Law (17 USC §108, "Limitations on exclusive rights: Reproduction by libraries and archives") and the Guidelines for the Proviso of Subsection 108(2g)(2) prepared by the National Commission on New Technological Uses of Copyrighted Works.

5. PRINTED COURSE PACKS AND ELECTRONIC RESERVE

5.1 The Licensee may, subject to clause 6 below, incorporate parts of the Archived Materials in printed Course Packs and Electronic Reserve collections for the use of Authorized Users in the course of instruction at the Licensee's institution. Each such item shall carry appropriate acknowledgement of the source, listing title and author of the extract, title and author of the work, and the publisher. Electronic copies of such items shall be deleted by the Licensee when they are no longer used for such purpose. Course packs in non-electronic non-print perceptible form, such as audio or Braille, may also be offered to Authorized Users who, in the reasonable opinion of the Licensee, are visually impaired.

6. PROHIBITED USES

- 6.1 The Licensee may not:
 - 6.1.1 intentionally remove or alter the authors' names or the Publisher's copyright notices or other means of identification or disclaimers as they appear in the Archived Materials;
 - 6.1.2 systematically make print or electronic copies of multiple extracts of the Archived Materials for any purpose other than for printed Course Packs and electronic reserves under 5.1;
 - 6.1.3 mount or distribute any part of the Archived Material on any electronic network, including without limitation the Internet and the World Wide Web, other than the Secure Network and through other networks for interlibrary lending.
- 6.2 The Publisher's permission must be obtained in order to:
 - 6.2.1 use all or any part of the Archived Materials for any Commercial Use;
 - 6.2.2 systematically distribute the whole or any part of the Archived Materials to anyone other than Authorized Users:
 - 6.2.3 publish, distribute or make available the Archived Materials, works based on the Archived Materials, or works which combine them with any other material, other than as permitted in this License.
 - 6.2.4 Fair Use. Nothing in this License shall in any way exclude, modify or affect any of Licensee's statutory or common law rights under the copyright laws of the United States.

7. PUBLISHER'S UNDERTAKINGS

7.1 The Publisher warrants to the Licensee that the Archived Materials do not infringe the copyright or any other proprietary or intellectual property rights of any person. The Publisher shall indemnify and hold the Licensee harmless from and against any loss, damage, costs, liability, and expenses (including reasonable legal and professional fees) arising out of any legal action taken against the Licensee claiming actual or alleged infringement of such rights. This indemnity shall survive the termination of this License for any reason. This indemnity shall not apply if the Licensee has amended the Archived Materials in any way not permitted by this License.

7.2 The Publisher shall:

- make the Archived Materials available to the Licensee from the Server. The Publisher will notify the Licensee and Representative at least ninety (90) days in advance of any anticipated specification change applicable to the Archived Materials. If the changes render the Archived Materials less useful to the Licensee, the Licensee may within sixty days of such notice treat such changes as a breach of this License under clause 10.1.3 and 10.3.
- provide the Licensee and Representative, within 30 days of the date of this License, 7.2.2 with information sufficient to enable the Licensee to access the Archived Material.
- 7.2.3 use diligent efforts to ensure that the Server has sufficient capacity and bandwidth to support the usage of the Licensee at a level commensurate with the standards of availability for information services of similar scope operating via the World Wide Web, as such standards evolve from time to time over the term of this License.
- 7.2.4 use diligent efforts to make the Archived Materials available to the Licensee and to Authorized Users at all times and on a twenty-four hour basis, except for routine maintenance (which shall be notified to the Licensee in advance wherever possible), and to restore access to the Archived Materials as soon as possible in the event of an interruption or suspension of the service.
- 7.3 The Publisher reserves the right at any time to withdraw from the Archived Materials any item or part of an item for which it no longer retains the right to publish, or which it has reasonable grounds to believe infringes copyright or is defamatory, obscene, unlawful, or otherwise objectionable. The Publisher shall give written notice to the Licensee of such withdrawal. If the withdrawal results in the Archived Materials being no longer useful to the Licensee, the Licensee may within sixty days of such notice treat such changes as a breach of this License under clause 10.1.3 and 10.3.
- 7.4 The Publisher reserves the right to terminate this License under clause 10.1.4 and withdraw access to the Journal and Archived Materials if the Publisher ceases to own the Journal.
- 7.5 Except as expressly provided in this License, the Publisher makes no representations or warranties of any kind, express or implied, including, but not limited to, warranties of design, accuracy of the information contained in the Archived Materials, merchantability, or fitness of use for a particular purpose. The Archived Materials are supplied 'as is'.
- 7.6 Under no circumstances shall the Publisher be liable to the Licensee or any other person, including but not limited to Authorized Users, for any special, exemplary, incidental, or consequential damages of any character arising out of the inability to use, or the use of, the Archived Materials. Irrespective of the cause or form of action, the Publisher's aggregate liability for any claims, losses, or damages arising out of any breach of these provisions shall in

no circumstances exceed the Fee paid by Licensee to the Publisher under this License for the Subscription Period during which such claim, loss, or damage occurred.

7.7 The Publisher shall invoice the Licensee for the Fee and Maintenance Fee and the Licensee shall pay said Fee and Maintenance Fee as detailed in clause 8.2 below. The Maintenance Fee shall be subject to change at the Publisher's sole discretion, but shall not amount to an increase of more than 6 in any one year. In the event that the Licensee does not agree to the Maintenance Fee for any one particular year, either party shall be entitled to terminate this License under clause 10.1.2.

8. LICENSEE'S UNDERTAKINGS

- 8.1 The Licensee shall:
 - 8.1.1 use reasonable efforts to inform Authorized Users of the terms and conditions of this License;
 - 8.1.2 use reasonable efforts to monitor compliance and upon becoming aware of any unauthorized use take reasonable and appropriate steps, including disciplinary action, to cease such activity;
 - 8.1.3 use reasonable efforts to issue passwords or other access information only to Authorized Users;
 - 8.1.4 provide the Publisher, within 30 days of the date of this Agreement, with information sufficient to enable the Publisher to provide access to the Archived Material in accordance with its obligation under clause 7.2.2. Should the Licensee make material changes to such information, it will notify the Publisher not less than ten (10) days before the change takes effect.
 - 8.1.5 use reasonable efforts to permit only Authorized Users access to the Archived Materials.
- 8.2 The Licensee shall, in consideration for the rights granted under this License, pay the Fee within thirty (30) days of receipt of invoice and, following the first year of the Term, pay the Maintenance Fee within thirty (30) days of receipt of invoice and, if applicable, within thirty (30) days of receipt of invoice relating to each subsequent Term. For the avoidance of doubt, the Fee and Maintenance Fee shall be exclusive of any sales, use, value added, or similar taxes and the Licensee shall be liable for any such taxes in addition to the Fee and Maintenance Fee.

9. UNDERTAKINGS BY BOTH PARTIES

9.1 Each party shall use all reasonable efforts to safeguard the intellectual property, confidential information, and proprietary rights of the other party, except as required by law or governmental rules or regulations.

10. TERM AND TERMINATION

- 10.1 In addition to the termination provisions of 2.2, this License shall be terminated:
 - 10.1.1 if the Licensee defaults in making payment of the Fee as provided in this License and fails to remedy such default within sixty (60) days of notification in writing by the Publisher;
 - 10.1.2 if the Licensee does not agree to an increase in the Maintenance Fee in any one particular year;
 - 10.1.3 if either party commits a material or persistent breach of any term of this License and fails to remedy the breach (if capable of remedy) within thirty (30) days of notification in writing by the other party;
 - 10.1.4 if the Publisher no longer owns the Journal;
 - 10.1.5 if either party becomes insolvent or becomes subject to receivership, liquidation, or similar external administration:
 - 10.1.6 if access, capacity, or technical services of the Publisher or Publisher's representative are incapable of providing reliable use of the Archived Materials or otherwise frustrate the intent of Licensee in entering into this License and such technical issues cannot be resolved by the Publisher or Publisher's representative within thirty (30) days of notification in writing from Licensee.
- 10.2 Except as otherwise provided herein, on termination all rights and obligations of the parties automatically terminate except for obligations in respect of Archived Materials to which access continues to be permitted in the form of electronic files, as detailed in clause 2.3 above. The Licensee understands that provision and use of such electronic files shall continue to be subject to the same terms and conditions of those outlined in clauses 3 and 6 above.
- 10.3 On termination of this License by the Licensee for cause, as specified in clause 10.1.3 and 10.1.6 above, the Publisher shall repay promptly and within thirty (30) days from termination the proportion of the Maintenance Fee that represents the paid but unexpired part of the year in which termination occurs. The publisher shall repay a portion of the Fee if lost before a term of ten (10) years. Repayment shall be equal to find the total fee for that particular journal multiplied by the number of years remaining in the ten (10) year term.
- 10.4 Where the Publisher terminates this License under clause 10.1.4 or clause 10.1.3 above due to a breach by the Licensee of the terms of clauses 6.1 and 8.1 the Publisher shall be entitled to terminate the Licensee's access to the Archived Materials upon giving written notice and the Licensee shall not be entitled to receive any electronic files of the Archived Materials. Licensee shall be entitled to a refund of any fees or pro-rata portion thereof paid by Licensee for any remaining period of the Agreement from the date of termination if terminated before a term of ten (10) years. Repayment shall be equal to the total fee for the Licensed Materials multiplied by the number of years remaining in the ten (10) year term.

11. GENERAL

- 11.1 This License constitutes the entire agreement of the parties and supersedes all prior communications, understandings, and agreements relating to the subject matter of this License, whether oral or written.
- Alterations to this License and to the Schedules to this License are only valid if they are recorded in writing and signed by both parties.
- 11.3 This License may not be assigned by either party to any other person or organization, nor may either party sub-contract any of its obligations, except as provided in this License in respect of the Representative and the management and operation of the Server and the Publisher's Representative, without the prior written consent of the other party.
- 11.4 If rights in all or any part of the Archived Materials are assigned to another publisher, the Publisher shall ensure that the terms and conditions of this License are maintained.
- Any notices to be served on either of the parties by the other shall be sent by prepaid recorded delivery or registered post to the address of the addressee as set out in this License or to such other address as notified by either party to the other as its address for service of notices. All such notices shall be deemed to have been received within 14 days of posting.
- 11.6 Neither party's delay or failure to perform any provision of this License, as result of circumstances beyond its control (including, without limitation, war, strikes, floods, governmental restrictions, power, telecommunications or Internet failures, or damage to or destruction of any network facilities) shall be deemed to be, or to give rise to, a breach of this License.
- 11.7 The invalidity or unenforceability of any provision of this License shall not affect the continuation or enforceability of the remainder of this License.
- 11.8 Either party's waiver, or failure to require performance by the other, of any provision of this License will not affect its full right to require such performance at any subsequent time, or be taken or held to be a waiver of the provision itself.
- This License shall be governed by and construed in accordance with the State of California law; the parties irrevocably agree that any dispute arising out of or in connection with this License will be subject to and within the jurisdiction of the courts of the State of California.


