TERMS OF USE

Conquest Systems, Inc. ("Conquest") offers you ("Licensee") access to a vast collection of information collected by Conquest and integrated into a database system, together with graphical user interfaces, data exploration tools and other associated software programs that access, analyze and display information (the "Database(s)"), which collectively may be accessed via the Internet on the DATA-PLANET™ web site at www.DATA-PLANET.com or other web sites via distribution and access partners (the "Site(s)"). The Database(s) and all other services provided by Conquest are the "Services." The Services are governed by this Terms of Use agreement executed or assented between Licensee and Conquest). If Conquest ceases to make the Licensed Materials available online, the data sheets, metadata records and data files will be made available for download to the Licensee in electronic format and Licensee may continue make the Licensed Materials available to Authorized Users subject to the terms of use outlined in this agreement.
