# AMENDMENT TO KINOKUNIYA BOOK STORE LICENSE AGREEMENT

The means by which Licensee shall have access to such Licensed Materials shall be in a manner and form substantially equivalent to the means by which access is provided under this Amendment.

Upon request of Licensee, Licensee may receive from Licensor and/or create one (1) copy of the entire set of Licensed Materials to be maintained as a backup or archival copy during the term of this Agreement, or as required to exercise Licensee's rights under the 'Perpetual License' section of this Amendment.

Should there be a conflict between this agreement and any other vendor-generated, web accessible terms and conditions, whether now knewn or hereinafter generated, then this Amendment and Agreement (as defined above) controls

This Agreement shall be renewable at the end of the current term for one year unless either party gives written notice of its intention not to renew thirty (30) days before expiration of the current term.


